





ANALYSIS: This program is not on track to meet the goal for 2021, due to lack of housing stock and high home prices caused a decline of HBE customers.







ABOUT: For Addison, Rutland, Bennington Counites, low income, lending/grants to repair homes and 1-4 unit apts.




